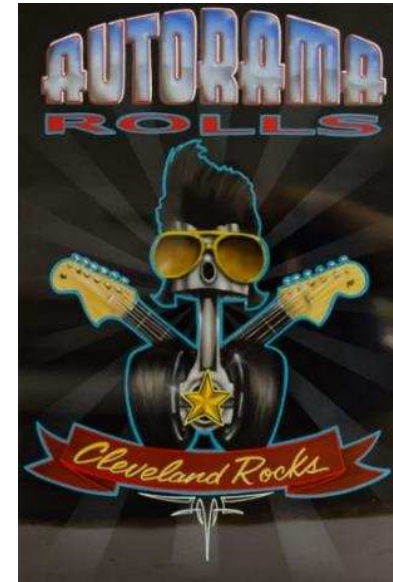
1st Place \$500 Prize

Winning is contingent upon fulfilling all requirements set forth herein in a timely manner.

The 2019 show will take place March 15 – 17, 2019 at the I-X Center.

USAGE/THEME: KRAZY PAINT PINSTRIPERS WILL CREATE A DESIGN FOR THE 2019 I-X PISTON POWERED AUTO-RAMA THAT WILL INCLUDE ANY ONE OF THE FOLLOWING PHRASES/THEMES:

THE 2019 THEME:

In 2019 Cleveland continues its reputation as an “All-Star” City. In March, Cleveland will play host to the Summit Racing Equipment Show I-X Piston Powered Auto-Rama where the All Stars are the Cars!!!

All entries become the property of the Sponsor and will not be returned. All entries will become auction items at the 2019 Charity Panel Jam Auctions at the 2019 I-X Piston Powered Auto-Rama.

NON-DIGITAL DESIGN PARAMETERS: The work should be created on any 12" x 18" medium. Artists/Designers are allowed to submit any number of original entries, however, you may not submit the same entry more than once. The 2019 Krazy Paint Pinstripers Official Design Contest reserves the right, in its sole discretion, to restrict participation in the Contest to any person at any time for any reason and/or to disqualify any entry at any time for any reason.

DIGITAL DESIGN PARAMETERS: The original artwork file should be created at 12" x 18" size (50cm x 70cm, 2953x4134 pixels), portrait oriented format only. IMPORTANT* Create two versions of your artwork file. The original file should be high-resolution 300 dpi in CMYK color mode. The second file should be low-resolution 72 dpi in RGB Color Mode in .jpeg, .jpg, .eps or .pdf format for entry submission via email.

NUMBER OF ENTRIES: Artists/Designers can submit any number of original entries, however, you may not submit the same entry more than once. The 2019 Krazy Paint Pinstripers Official Design Contest reserves the right, in its sole discretion, to restrict participation in the Contest to any person at any time for any reason and/or to disqualify any entry at any time for any reason

IMPORTANT NOTICE TO CONTESTANTS: You are only allowed to submit original unpublished works for the Design Contest. Also, do NOT publish your submitted design on Facebook or other social media until after the winner is announced. Each Entry must be an original unpublished work that you have created that does not include material in which a third party has intellectual property rights.

JUDGING AND WINNER SELECTION: All entries will be judged by a panel of five judges, applying the following criteria: (i) originality/uniqueness of design/appearance (50%); (ii) appropriateness to theme (25%); and (iii) creativity (25%). The three winners will be notified on October 27, 2017. The decisions of the judges are final and binding.

PRIZES: The 1st place prize is \$500, 2nd place prize is \$250, 3rd place prize is \$100

NOTIFICATION OF WINNER: Winner will be notified by email, telephone, message and/or postal mail, using the information supplied at time of entry, and may be required to sign and return an affidavit of eligibility, publicity and liability release, along with an assignment of all rights in and to his/her entry (including copyright and a waiver of any moral rights to the extent allowed by law), within seven (7) days of notification AND before receiving any prize in whole or in part. Potential winner may also be required to provide additional documents as may be required by Sponsor to confirm and/or assign rights in the entry. Failure to comply when requested may result in disqualification and selection of an alternate winner. No liability is assumed for any winner notification that is lost, intercepted or not received for any reason.
